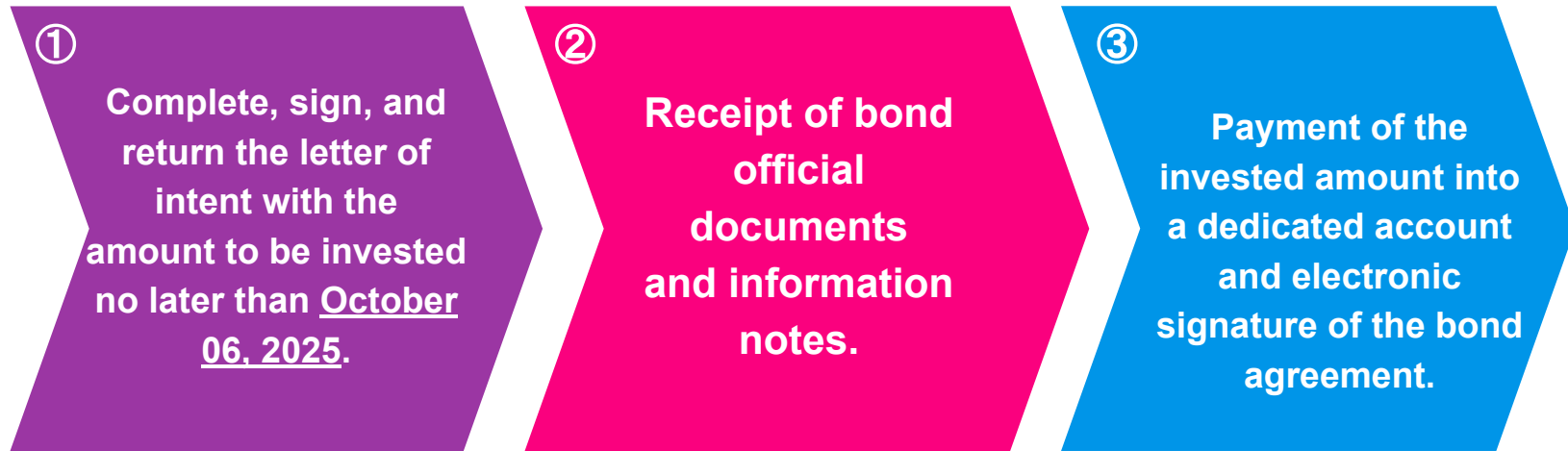

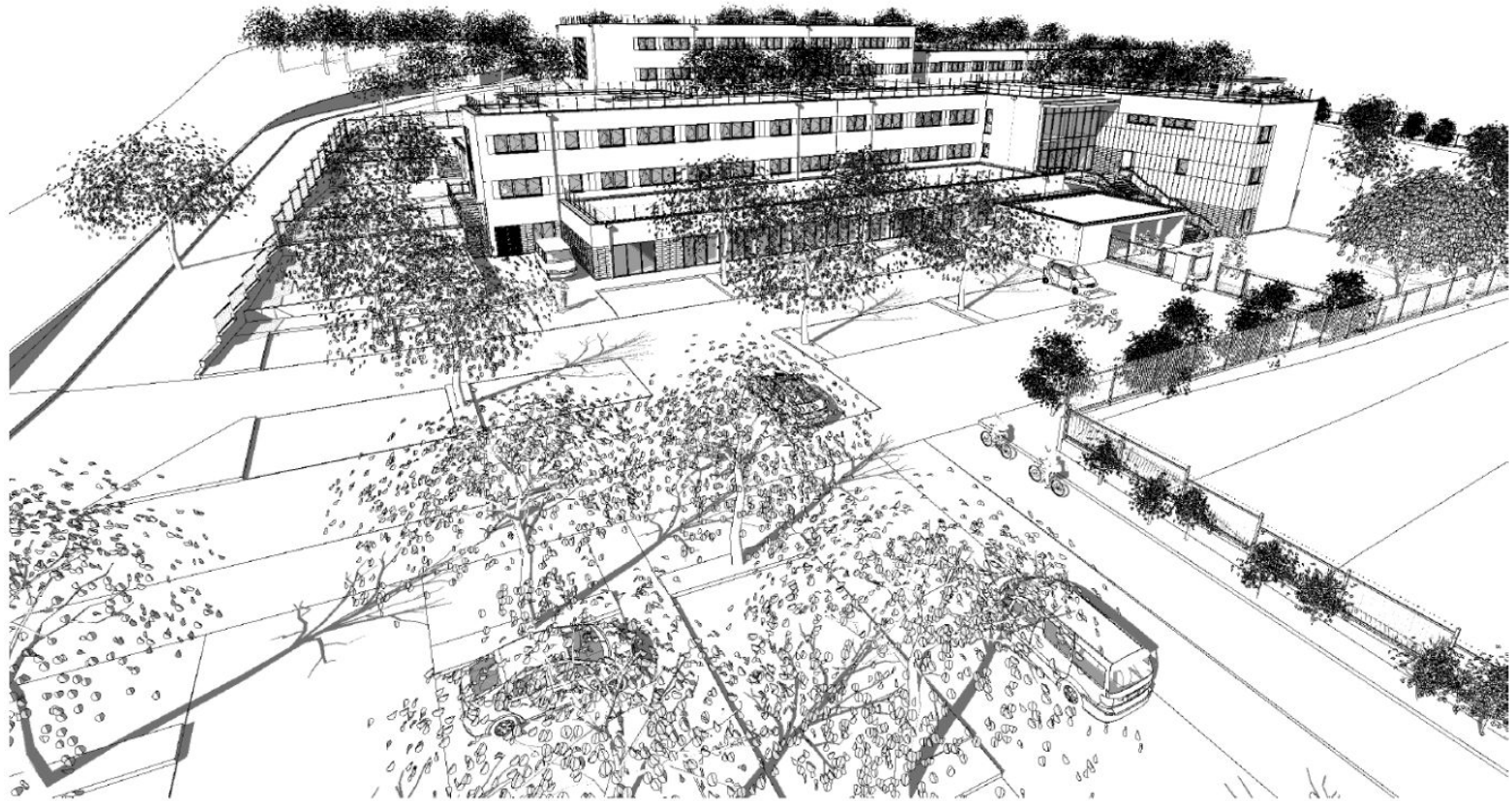

EBIHS is an association. It is managed by a board of directors and its articles of association allow it to issue bonds.

The association's accounts are audited by a certified public accountant and an auditor. The bond agreement is subject to approval by the auditor.

The Sunflowers company was set up to facilitate the management of the real estate project and the future campus. Sunflowers has taken out a 15-year real estate lease with a banking pool. The EBIHS association is the majority shareholder in Sunflowers.
